**Re: Prairie Provident Resources Canada Ltd. – Notice of Preliminary Screening Determination – Renewal Application for Land Use Permit – Miscellaneous – Abandonment and Reclamation Program – Fort Liard area, NT**

The Mackenzie Valley Land and Water Board (Board) met on December 4, 2025, and considered the Application Package from Prairie Provident Resources Canada Ltd. (Prairie Provident) for Land Use Permit (Permit) MV2025X0017 for the Mount Coty K-02 and South Pointed Mountain L-68 Abandonment and Reclamation Program (Project) in accordance with the *Mackenzie Valley Resource Management Act* (MVRMA).

The Board completed a preliminary screening of the Project on March 18, 2003, under Permit MV2003A0005 for Mount Coty K-02<sup>1</sup> and on June 24, 2010, under Permit MV2010A0016 for South Pointed Mountain L-68.<sup>2</sup> On August 2, 2018, Permit MV2018X0002 was issued, covering reclamation activities for both South Pointed Mountain L-68 and Mount Coty K-02 well sites, and was confirmed to be exempt from preliminary screening.<sup>3</sup> Prairie Provident has not proposed changes to the Project. Accordingly, the Board has determined that the Project is exempt from preliminary screening under Part 1, Schedule 1, section 2 of the Exemption List Regulations to the MVRMA. Consequently, no further preliminary screening was conducted.
